



Data Processing Notice related to the CEEGEX “Joule demo” Webinar

CEEEX Central Eastern European Gas Exchange Private Company Limited by Shares (registered office: 1134 Budapest, Dévai u. 26-28, company registration number: 01-10-047091, tax number: 23408612-2-41, contact: info@ceegex.hu, hereinafter as: “**Data Controller**”) shall describe the data processing actions implemented in relation to the CEEEX “Joule demo” Webinar to be held on 6th August 2025 in MS Teams environment (hereinafter as: „**Webinar**”) in this Data Processing Notice (hereinafter as: “**Data Processing Notice**”).

This Data Processing Notice was prepared in line with Regulation (EU) 2016/679 of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (hereinafter as: “**GDPR**”), with due consideration of the provisions of Act CXII of 2011 on Informational Self-determination and Freedom of Information (hereinafter as: “**Information Act**”) as well, and the terms and expressions used herein shall be interpreted according to the definitions specified in Article 4 of the GDPR, and – in certain Sections – in Section 3 of the currently effective Information Act.

As data subject, you may at any time request more detailed information on the processing of your personal data or access your personal data, request their rectification, erasure or restriction of their processing, and may object to the processing of personal data and exercise your right to data portability. Please be informed that you have the right to withdraw your consent at any time. The withdrawal shall not affect the legal basis of the previous data processing.
